**THE ANNUAL GENERAL MEETING HELD ON 11 MAY 2018**

At the Annual General Meeting of Shenwan Hongyuan (H.K.) Limited (the “Company”) held at the TALK Meeting Room at 2nd Floor, OZO Wesley Hong Kong, 22 Hennessy Road, Wanchai, Hong Kong, on 11 May 2018 (the “AGM”), a poll was taken for voting on all the proposed resolutions as set out in the Notice of Annual General Meeting dated 11 April 2018.
