**POLL RESULTS OF
THE ANNUAL GENERAL MEETING HELD ON 22 MAY 2020**

At the Annual General Meeting of Shenwan Hongyuan (H.K.) Limited (the “**Company**”) held at Empire Room I, 1/F, Empire Hotel Hong Kong, 33 Hennessy Road, Wanchai, Hong Kong, on Friday, 22 May 2020 (the “**AGM**”), a poll was taken for voting on all the proposed resolutions as set out in the Notice of Annual General Meeting dated 21 April 2020.

As at the date of the AGM, the number of shares in issue of the Company was 1,561,138,689 shares, which was the total number of shares entitling the holders to attend and vote for or against all resolutions at the AGM. There were no restrictions on any shareholders casting votes on any of the proposed resolutions at the AGM.
