The Product

The Shenyin Wanguo RMB Mainland Investment Fund (the "Sub-Fund") invests primarily in RMB-denominated and settled debt securities issued in the PRC through a RQFII quota of the RQFII Holder which is a holding company of the Fund Manager.

Risk Disclosure

- The investments of the Sub-Fund are concentrated on securities related to the PRC market. Investment in the PRC market is exposed to various emerging market risks including political, economic, regulatory, legal, foreign exchange, settlement and liquidity risks.
- The Sub-Fund invests in securities through a RQFII which is subject to applicable rules and regulations imposed by the PRC authorities. The RQFII rules are novel in nature, and their application may depend on the interpretation of the Chinese authorities. Any changes to the relevant rules may have an adverse impact on the investment of investors in the Sub-Fund.
- Renminbi is currently not freely convertible and is subject to exchange controls by the Chinese government. Investors may be adversely affected by the movement of the exchange rates between Renminbi and other currencies.
- The Sub-Fund may be exposed to risks associated with changes in PRC tax laws. Such changes may have retrospective effect and may adversely affect the Sub-Fund.
- Investment in the Sub-Fund is exposed to interest rate risk that applies to debt securities. The macro-economic policies and controls of the Chinese government will have significant influence over the capital markets in the Mainland China.
- The Sub-Fund is exposed to credit risk arising from issuers of the RMB denominated debt securities in which it invests. Such securities are typically unsecured debt obligations and are not supported by collateral. The Sub-Fund is therefore fully exposed to the credit/insolvency risk of its counterparties as an unsecured creditor.

The Manager may or may not dispose of the securities being downgraded. If the Sub-Fund continues to hold such securities, it will be exposed to additional risk of loss.
- The RMB denominated debt securities market is at a developing stage and the trading volume may be lower than those of more developed markets. The Sub-Fund may invest in debt securities which are not listed. Even if the debt securities are listed, the market for such securities may be inactive. - Some of the RMB denominated debt securities invested by the Sub-Fund may be unrated or below investment grade. Such debt securities are exposed to greater risk because of generally lower credit worthiness and liquidity, greater fluctuation in value and higher chance of default than investment grade bonds.

- Distributions of the Sub-Fund may be paid from income and/or capital of the Sub-Fund. The Sub-Fund or the Fund Manager may at its discretion pay dividend out of capital of the Sub-Fund. The payment of dividends out of capital represents and amounts to a return or withdrawal of part of original investment or from any capital gains attributable to that original investment. Any distributions involving payment of dividends out of the Sub-Fund's capital may result in an immediate reduction of the Net Asset Value per Unit. The Sub-Fund or the Fund Manager may amend the Sub-Fund's distribution policy with respect to payment of dividend out of the capital of the Sub-Fund subject to the SFC's prior approval and by giving not less than one month's prior notice to investors. The compositions of the dividends (i.e. the relative amounts paid out of (i) net distributable income and (ii) capital) for the last 12 months are available from the Fund Manager upon request and on the website of the Fund Manager at <http://www.swhyhk.com>. Market Review

In early April 2025, the Chinese bond market exhibited the characteristics of "reduced issuance volume, diverging yields, and policy support." The supply pressure on government bonds was significant, credit bond spreads narrowed, liquidity remained ample, and technology innovation bonds became a key focus of policy support. The total issuance for the month amounted to RMB 1,491.67 billion, a month-on-month decline of 32.59%. Among them, RMB 1.34 trillion worth of government bonds were issued, while RMB 34.848 billion worth of technology innovation bonds were issued.

In terms of yields, the 1-year government bond yield stood at 1.47%, the 3-year at 1.65%, and the 10-year at 1.69%, with term spreads narrowing further. The 1-year AA- credit bond yield declined by 15 basis points (BP), while the average credit spread narrowed by 12 BP.

Market Outlook and Strategy

Looking ahead, on the economic front, while the PMI may continue its moderate recovery, pressures remain on real estate investment and consumer demand. The progress of U.S.-China tariff negotiations may impact market risk appetite. On the liquidity front, the central bank is expected to maintain a "dual stability in quantity and price" strategy, utilizing reverse repos and MLF (Medium-term Lending Facility) operations to stabilize liquidity fluctuations.

Comments on portfolio

This month, the net asset value (Class I) return of RQFII funds was 0.54%, while the ChinaBond Comprehensive Full-Price Index (CBCFPI) posted a monthly return of -0.19%. The fund outperformed the index mainly due to the strong performance of bank convertible bonds held by the fund. As of the end of May, the portfolio held approximately 94.81% in bonds, with convertible bonds accounting for 23.86%, remaining largely unchanged from the previous period. Public funds/equities accounted for 1.81%, further reducing equity allocation. Most of the corporate bonds in the portfolio were investment-grade. As of the end of May, the fund's average duration was 1.23 years, and the average yield to maturity was 0.05%. The portfolio held a total of 26 securities, achieving adequate diversification.

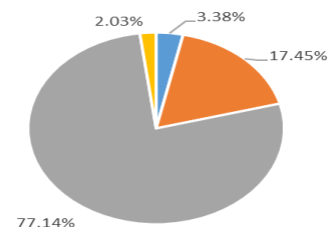
