The Product

The Shenyin Wanguo RMB Mainland Investment Fund (the "Sub-Fund") invests primarily in RMB-denominated and settled debt securities issued in the PRC through a RQFII quota of the RQFII Holder which is a holding company of the Fund Manager.

Market Review

In September, the PMI index recovered to 50.1%, which was above the line of prosperity. Inter-bank liquidity was slightly tighter than in July-August, with DR001 and DR007 both closing above 2%. Considering the impact of the long holiday, the overall liquidity did not turn around. The RMB depreciated more this month, and the exchange rate affected the China Bond Composite Full Price Index (CBCFPI), which fell by 0.22% this month. The yields of key interest rate treasury bonds with maturities of 1, 3, 5, 7 and 10 years changed by 11 basis points/14 basis points/18 basis points/14 basis points/14 basis points respectively, and the yield curve as a whole rose.

Market Outlook and Strategy

Looking forward to the fourth quarter of 2022, the FED will continue quick rate hike to curb inflation as well as the uncertainty caused by the epidemic still exists. It is expected that more economic measures to stabilize growth will be introduced, especially the fields related to infrastructure/real estate/new energy will be the focus of policy efforts. Domestically, monetary policy will remain loose and liquidity will remain reasonably sufficient. In response to the recent rapid depreciation of the RMB, we believe that the RMB exchange rate will stabilize with the gradual completion of the U.S. interest rate hike, and will not become an important risk point for the bond market


Comments on portfolio

In June, our ROFII Fund's NAV (I Class) decreased by 0.46%, while China bond Composite Full Price Index (CBCFPI) decreased by 0.22%. fund NAV underperformed the benchmark. In terms of Fund's asset allocation, after the issuer redeemed GLCONS 24, the IM increased the position of convertible bonds. At month end, our portfolio has 89.11% in bond, 2.32% in public fund/equity and 8.57% in cash/MMF. We have 17.61% in sovereign bonds/rate securities, and most corporate/enterprise bonds are investment grade. By the end of September, the Fund has an average duration of 2.44 years and average yield-to-maturity of 2.91%. The Fund is adequately diversified in 39 names


