Market Review

In April, the manufacturing PMI in China slipped into the weak contraction zone, with the production part barely staying above the 50 threshold. Both the new order and new export order sub-indices of the demand category fell below 50. These data indicate that industrial enterprises are still in the bottoming-out phase. Meanwhile, starting this month, bank deposit interest rates have been gradually lowered, following the strong growth in credit in the previous period. As a result, there has been a significant downward shift in government bond yields. 1/3/5/7/10 year tenor key rate treasury YTMs changed by -12.6bps/-7.6bps/-8.8bps/-9.3bps/-8.2bps respectively. The China bond Composite Full Price Index (CBCFPI) closed at 124.2189 in April from 123.779 in March, an increase of 0.36%.

Market Outlook and Strategy

Looking ahead, the pace of real estate recovery in April was relatively sluggish, with sales areas in 30 cities declining. High-frequency data also began to contract, while the volatility of commodity prices suppressed the performance of upstream industries. Currently, government bond yields have decreased significantly this year, and the probability of further downward movements is relatively low. Therefore, the duration of this portfolio will be moderately controlled. However, with external demand being weak and weak domestic confidence, there is still motivation for a more relaxed environment to maintain economic recovery. It is expected that the space for the yield curve to turn upwards will be relatively limited. Given the current unstable state of economic recovery, fixed income products have value for allocation.


Comments on portfolio

In March, our RQFII Fund's NAV (I Class) increased by +0.17%, while China bond Composite Full Price Index (CBCFPI) increased by +0.36%, fund NAV underperformed the benchmark. In terms of Fund's asset allocation, our portfolio has 82.41% in bond, 5.29% in public fund/equity and 12.29 % in cash/MMF. Most corporate/enterprise bonds are investment grade. By the end of April, the Fund has an average duration of 2.09years and average yield-to-maturity of 1.46%. The Fund is adequately diversified in 31 names.


