The Product

Market Review

Due to negative factors such as the Russian-Ukrainian conflict and China's redemption surge of bank wealth management products, China's bond yield continued to rise this month. In the middle of the month, the MLF rate remained unchanged, which is out of expectation. The economic data from January to February implied an economic upturn. All the factors lead to the yield rise of China's bond. Then by the end of this month, due to COVID-19 outbreak in mainland China, the downward pressure on the economy has increased, and China's bond market showed a recover accordingly. The China bond Composite Full Price Index (CBCFPI) closed at 122.92 in March from 123.17 in February, a decrease of 0.20%. 1, 3, 5, 7, 10 year tenor key rate treasury YTMs changed by +8bps, +12bps, +6bps, +4bps and +1bps respectively. An upward shifting yield curve is observed.

Market Outlook and Strategy

In 2022, we expect an increase in carryover of fiscal reserves from this year. We also expect a policy shift towards countercyclical easing, featuring a corporate tax cut, pro-consumption measures, and green infrastructure boost. Looking ahead, more efforts should be made to stabilize the macroeconomy and keep the economy running within a reasonable range. We expect proactive fiscal policy and a prudent monetary policy. And the monetary policy should be appropriate with liquidity to be kept reasonably sufficient.


Comments on portfolio

In March, our RQFII Fund's NAV (I Class) decreased by 0.59%, while China bond Composite Full Price Index (CBCFPI) decreased by 0.20%, slightly underperforming the benchmark. In terms of Fund's asset allocation, our portfolio has 90.4% in bond, 3.4% in public fund/equity and 6.2% in cash/MMF. We have 22.8% in sovereign bonds/rate securities, 67.6% in corporate/enterprise bonds. Our corporate/enterprise bonds are mostly investment grade: AAA 63.9%, AA+ or below 3.6%. By the end of March, the Fund has an average duration of 2.82 years and average yield-to-maturity of 2.54%. The Fund is adequately diversified in 47 names and our Top 10 holdings have an aggregate weight of 57.7%.


