Market Review

During the current period, the valuation yield of government bonds remained volatile, with a decrease of 5bps/5bps/6bps/1bps throughout the month. The yield curve further steepened, and bond prices remained at high levels. On the macroeconomic front, there was a divergence between the April PMI data and high-frequency data, with all three major indices indicating expansion. CPI also showed a mild rebound, with a year-on-year increase of 0.3%, while PPI decreased by 2.5% year-on-year. The released social financing data at the end of the period fell well below market expectations, with negative year-on-year growth in social financing in April and a 1.4% decrease in M1. Despite the impact of noneconomic factors such as measures to curb financial speculation and the discontinuation of manual interest rate adjustments, leading to deposit relocation, the insufficient domestic demand remains the primary reason. In April, the national industrial value-added increased by 6.7% vear-onyear, accelerating by 2.2 percentage points compared to the previous month, with a month-on-month growth of 0.97%, indicating increased industrial production activities. The total retail sales of consumer goods in April grew by 2.3% year-on-year, a decrease of 0.8 percentage points compared to March, showing a downward trend for the fourth consecutive month.

Market Outlook and Strategy

The economic data in April showed mixed results, indicating that the signs of a stable economy are still uncertain. Despite the central bank's repeated statements about the low bond yields deviating from the actual economic conditions, bond yields have remained at low levels, with the 10-year government bond yield staying below 2.30%. In the near future, it is expected that with the influence of policies on both the supply and demand sides, the growth rate of real estate development investment is expected to gradually stabilize. This will be supported by the accelerated issuance of ultra-long-term special government bonds and specific bonds, as well as policy measures promoting "old-for-new" replacements in real estate and consumer goods, and equipment upgrading and renovation. Consumption is expected to gradually recover.


Comments on portfolio

In May, our RQFII Fund's NAV (I Class) changed by 0.14%, while China bond Composite Full Price Index (CBCFPI) changed by 0.23%, fund outperforming the benchmark. In terms of Fund's asset allocation, our portfolio has 91.15% in bond, 2.39% in public funds/equities, slightly increased allocation to convertible bond, and 6.46% in cash/MMF. Most corporate/enterprise bonds are investment grade. By the end of May, the Fund has an average duration of 1.32 years and average yield-to-maturity of 1.71%. The Fund is adequately diversified in 27 names.
