# Shenyin Wanguo RMB Mainland Investment Fund

**The Product**

The Shenyin Wanguo RMB Mainland Investment Fund (the "Sub-Fund") invests primarily in RMB-denominated and settled debt securities issued in the PRC through a RQFII quota of the RQFII Holder which is a holding company of the Fund Manager.

**Risk Disclosure**

- The investments of the Sub-Fund are concentrated on securities related to the PRC market. Investment in the PRC market is exposed to various emerging market risks including political, economic, regulatory, legal, foreign exchange, settlement and liquidity risks.
- The Sub-Fund invests in securities through a RQFII which is subject to applicable rules and regulations imposed by the PRC authorities. The RQFII rules are novel in nature, and their application may depend on the interpretation of the Chinese authorities. Any changes to the relevant rules may have an adverse impact on the investment of investors in the Sub-Fund.
- Renminbi is currently not freely convertible and is subject to exchange controls by the Chinese government. Investors may be adversely affected by the movement of the exchange rates between Renminbi and other currencies.
- The Sub-Fund may be exposed to risks associated with changes in PRC tax laws. Such changes may have retrospective effect and may adversely affect the Sub-Fund.
- Investment in the Sub-Fund is exposed to interest rate risk that applies to debt securities. The macro-economic policies and controls of the Chinese government will have significant influence over the capital markets in the Mainland China.

Any distributions involving payment of dividends out of the Sub-Fund's capital may result in an immediate reduction of the Net Asset Value per Unit. The Sub-Fund or the Fund Manager may amend the Sub-Fund's distribution policy with respect to payment of dividend out of the capital of the Sub-Fund subject to the SFC's prior approval and by giving not less than one month's prior notice to investors. **Market Review**

In November, the manufacturing PMI was below expectations and remained in the contraction zone. Social retail sales showed a slight improvement, but it was mainly supported by a low base effect. Fixed asset investment was flat compared to the first ten months, with real estate development investment seeing a larger decline. Infrastructure investment remained stable, while manufacturing investment showed some growth. The November CPI fell more than expected by 0.5% yoy, and the PPI has been declining for 14 consecutive months, dropping by 3% yoy. In a weak demand environment, there's insufficient momentum for long-term yield to rise. 1,3,5,7, and 10 years bonds changed by 13bps/4.2bps/3.7bps/-2.1bps/-2.6bps. The China Bond Composite Full Price Index (CBCFPI) changed by about 0.19% this month, rising from last month's 124.6715 to 124.9128 this month.

**Market Outlook and Strategy**

The recovery's pace is now hindered, and its future is uncertain. Despite ongoing issuance of special government bonds affecting funding, given the weaker reality and ten-year government bond yields significantly higher than the MLF rate, the chances of yields decreasing are higher. It's recommended to allocate longer-term bonds. Local debt resolve result in low default risk in LGFV bonds, which can be allocated to enhance portfolio returns.

**Comments on portfolio**

In November, our RQFII Fund's NAV (I Class) changed by -0.32%, while China bond Composite Full Price Index (CBCFPI) changed by 0.19%, fund NAV underperformed the benchmark. In terms of Fund's asset allocation, our portfolio has 91.49% in bond, 3.07% in public fund/equity and 5.44% in cash/MMF. Most corporate/enterprise bonds are investment grade. By the end of November, the Fund has an average duration of 2.06 years and average yield-to-maturity of 2.12%. The Fund is adequately diversified in 26 names.
