The items including P&L Cost, Average Buying Price, P&L, P&L Ratio, Floating P&L and Floating P&L Ratio (collectively referred to as "Average Cost") displayed on our trading platforms have their specific definitions and meanings and shall not be interpreted literally. The Service may be subject to technical or systematic error which may affect the accuracy, completeness, timeliness or correctness of the Service. Therefore users must be aware that the Service is provided for reference only and does not necessarily reflect the actual situation. Users shall not adopt the figures provided by the Service as the basis of their trading decision before they have a clear understanding on the implication of such figures and having verified the accuracy of such figures themselves. Users are advised to seek independent professional (including but not limited to financial and legal) advice before making any investment decision and users are further advised that any trades executed following or in reliance of the Service are taken at users' own risk for users' own account. Shenwan Hongyuan Securities (H.K.) Frequently Asked Questions (the "FAQs")

1. The definition

Item	Definition & Computation
Total Quantity	means quantity of stocks available for sale + quantity of stocks already sent out queuing up for sale but not yet executed in the market
P&L Cost	means the accumulated profit and loss cost of a stock after computing all buy and sell transactions but take no consideration of any cash dividends or corporate action within the stock's holding period. P&L Cost = (The accumulated values of a stock bought within the holding period - The accumulated values of a stock sold within the holding period) ÷ Total Quantity
Average Buying Price	means the average cost of a stock bought within the holding period inclusive of transaction costs. Such price only changes when there is a buy transaction, but remains unchanged when there is a sell transaction. Average Buying Price = The aggregated price of a stock bought within the
	holding period ÷ The aggregated quantity of a stock bought within the holding period
P&L	means the profit and loss of the Total Quantity of a stock. P&L = (Market Price - P&L Cost) × Total Quantity
P&L Ratio	means the profit and loss ratio of the Total Quantity of a stock. P&L Ratio = (Market Price — P&L Cost) ÷ P&L Cost





Floating P&L	means the profit and loss of the Total Quantity of a stock computed on the basis of its Average Buying Price.
	Floating P&L = (Market Price — Average Buying Price) × Total Quantity
Floating P&L Ratio	means the profit and loss ratio computed on the basis of its Average Buying Price.
	Floating P&L Ratio = (Market Price — Average Buying Price) ÷ Average Buying Price

2. Do the above Items applicable to other markets?

Yes, the above Items and theirs computation shall apply to all tradable markets of Shenwan Hongyuan.

3. How to read the above Items?

Users may download and install Shenwan Hongyuan's Qian Long trading platform in order to read the Items free of charge.

Users may also read the items through Shenwan Hongyuan's Consolidated e-Service services by login to their accounts with Shenwan Hongyuan.

4. When will the Items start to be computed?

The holdings of stocks which were transacted prior to the launch of the Service on each user account will not be taken into account in the computation of the Items. All the Items of such stocks will be displayed as "-" or "N/A". Items of a stock will only start to be computed by the system of the Service automatically in the following trade day after the holdings of that stock are all sold and the day-end Total Quantity becomes "0".





5. Will the transactions occurred during a trade day be taken into account in computing the Items?

For stocks traded during the trading day, the Service will only include the trade amount when computing the Items without taking into account the transaction costs. The transaction costs of such stocks will be processed after the end of the trading day through the settlement system and the Items will be re-computed thereafter. The re-computed Items shall only be displayed on the trading platform from the beginning of the next trading day.

6. Will P&L Cost appear negative?

P&L Cost will appear negative in the following situations:

- Situation 1, if the quantity of stock holdings in the user account becomes negative (it happens if user sells shares prior to the deposit of such shares into his/her/its account for settlement); or
- Situation 2, if the accumulated value of a stock bought within the holding period is less than its accumulated value sold within such period, in other words, the cost of the holdings of such stock has been diminished to zero.

7. What is market price?

- -Nominal price is adopted as market price in Hong Kong Market.
- -Last price is adopted as market price in Shanghai-Hong Kong Stock Connect.
- -Last traded price is adopted as market price in the U.S. Market if Shenwan Hongyuan receives trading order for a stock within the trade day. Otherwise, the closing price of the last trading day will be adopted as market price.
- -Previous closing price is adopted as market price in all other markets.

8. How to deal with deposit / withdrawal of shares?

The system of the Service will assume the price of any shares being transferred or physically deposited from any account other than Shenwan Hongyuan's user account to be zero ("0") and the P&L Cost will therefore be underestimated. Users shall adjust the P&L Cost and Average Buying Price manually through Shenwan Hongyuan's Qian Long trading platform and Shenwan Hongyuan's Consoliated e-Service.





When dealing with shares outbound transfer to other brokers or physical withdrawal of shares, the system of the Service will adopt the P&L Cost (including commission and transaction fee) of the last trade day as the price of such shares. Similarly, users shall adjust the P&L Cost and Average Buying Price manually through Shenwan Hongyuan's Qian Long trading platform and Shenwan Hongyuan's Consolidated e-Service.

9. Can P&L Cost and Average Buying Price be adjusted?

Users may adjust P&L Cost manually and the system of the Service will automatically adopt the adjusted P&L Cost as the Average Buying Price. After users have adjusted the P&L Cost manually, the system of the Service will not compute any transaction costs.

Please be noticed that the system of the Service allows manual adjustment to P&L Cost and Average Buying Price from 07:00 to 19:00 only.

10. Will corporate actions affect the Items?

The Service handles the computation of corporate actions including the bonus issues and share split / consolidation but excludes the computation of cash dividend, right issues and share placements. "*" is marked beside stock name to denote the computed Items have been deviated due to corporate actions not handled by the Service.

11. Is it necessary to adjust the P & L cost if there is a "*" beside the stock name?

The maker will remains until the P & L cost is adjusted.





12. Does mobile phone trading platform display the Items?

The mobile phone trading platform does not display the Items at the present stage. Users may access the Service through Shenwan Hongyuan Qian Long trading platform and Shenwan Hongyuan's Consolidated e-Service.

13. Is it necessary to upgrade the version of Shenwan Hongyuan Qian Long trading platform in order to use the Service?

Yes, users shall download from our website the Shenwan Hongyuan Qian Long trading platform version 4.1 or above for using the Service.

3. 如何查閱以上項目?

客戶可使用網上交易下載版 - 申萬宏源錢龍港股通及 通過網上綜合戶口 服務登入交易介面查閱以上各項目。

4. 以上項目由何時開始計算?

系統推出前,客戶賬戶所持有的股票一概不作均價計算;買入均價和盈虧成本價及相關數值會顯示 "-"或"N/A",直至其所持有的股票悉數出售後,該隻股份的日結持股數目變成零("0")時,在隨後的交易日重新購入才開始計算。





5. 常日進行之交易可計算以上項目嗎?
